


Why in Jiangsu?


Jiangsu Province leads China's service outsourcing industry. By the end of 2010, the offshore outsourcing amount in actual use reached US\$ 4bn, with 485,000 people employed in this field and more than 3,800 service outsourcing companies registered, each of the figure taking up about one third of China's total amount. Currently, Jiangsu has



established a service outsourcing industrial cluster featuring software outsourcing, bio-medicine R & D outsourcing, cartoon and animation outsourcing, Industry design outsourcing, financial services outsourcing, supply chain management, etc. and more and many world-famous

service outsourcers have established their offices in Jiangsu in Jiangsu one by one, including Microsoft, IBM, BearingPoint, Accenture, Capgemini, Britain-based UBI Group, Japan's Hitachi,
